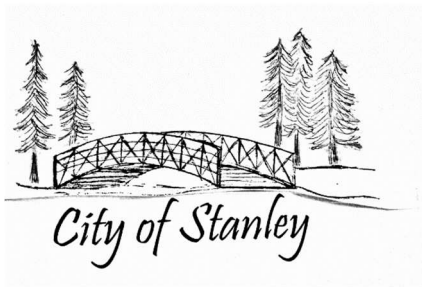

KENNEL CONSTRUCTION AND OPERATION

These provisions apply to commercial and noncommercial kennels. The regulations for animal shelter standards as set out in Section 7-1-3.

No permit shall be granted to an owner for the operation of an outdoor kennel unless the area within which the animals are to sleep, eat, or exercise shall be enclosed completely with a wire mesh fence with appropriate height and strength to ensure the confinement of said animals.

Every kennel shall be maintained and operated in a neat and sanitary manner. All refuse, garbage, and animal waste shall be removed at regular intervals so as to keep the surrounding area free from obnoxious odors. No owner of the kennel shall permit any animals to create unusual noise from barking, howling, or create any nuisance of any kind which unduly impairs the quiet and peaceful enjoyment of the surrounding area by other residents.

All Kennels are subject to inspection by the Stanley Police Department at reasonable hours upon request. All kennels must comply with all building and zoning codes.

The City Council may revoke any kennel permit for violation after reasonable notice and opportunity to be heard is given to the permit holder.

Council approval is required for all kennel permits. Each kennel permit shall be posted conspicuously on the kennel premises.

Please sign this form, provide current rabies vaccination information, pet license application, and bring appropriate fees to city hall for a kennel license and pet licenses.
