RELEASE AND HOLD HARMLESS AGREEMENT

In consideration of receiving permission from the City of Stanley, a Wisconsin municipal corporation ("City") to use property owned by the City (the "Property") for hunting, trapping, and other recreational purposes, the undersigned hereby releases the City of Stanley, along with their agents, officers, servants and employees, of and from any and all liability, claims, demands, actions, and causes of actions, whatsoever, arising out of or relating to any loss, damage or injury, including death, that may be sustained by the undersigned or any property of the undersigned arising out of or related to the undersigned's use of the Property.

The undersigned is duly aware of the risks and hazards inherent in using the Property for hunting, trapping, and other recreational purposes, including without limitation, the risk of injury, amputation, dismemberment, other serious injury, or death, and hereby elects voluntarily to use the Property. The undersigned hereby voluntarily assumes all risk of loss, damage or injury, including death, which may be sustained by the undersigned or any property of the undersigned while using said Property. Nothing in this release shall be construed as a waiver or limitation of the City's recreational and governmental immunities as set forth in Wis. Stat. §§ 895.52 or 893.80, or any other governmental or recreational immunities in law or equity.

This release shall be binding upon the signer hereof, heirs, personal representatives, and successors thereof.

In signing this release, the undersigned hereby specifically acknowledges and represents:

1. THAT HE/SHE HAS READ THE FOREGOING RELEASE, UNDERSTANDS IT AND SIGNS IT VOLUNTARILY AND WITH FULL KNOWLEDGE OF ITS CONTENT.

2. THAT THE UNDERSIGNED IS OVER AGE EIGHTEEN AND OF SOUND MIND.

3. THAT THE UNDERSIGNED HAS NOT PAID THE CITY OF STANLEY ANY COMPENSATION, MONETARY OR OTHERWISE, FOR THE PERMISSION TO USE THE PROPERTY FOR HUNTING, TRAPPING, AND OTHER RECREATIONAL PURPOSES.

4. THAT THE UNDERSIGNED UNDERSTANDS THAT THEY HAVE THE RIGHT TO BARGAIN OR NEGOTIATE ANY OF THE ABOVE TERMS WITH THE CITY OF STANLEY. BY SIGNING THIS AGREEMENT, THE UNDERSIGNED HEREBY ACKNOWLEDGES THEIR RIGHT TO BARGAIN AND WAIVES SAID RIGHT TO BARGAIN FOR DIFFERENT TERMS AND ACCEPTS THE TERMS STATED HEREIN.
